Case in point: Prop 65

California passed Prop 65, or the Safe Drinking Water and Toxic Enforcement Act of 1986, to protect drinking water sources from harmful chemicals. At least once a year, the Office of Environmental Health Hazard Assessment (EHHA) publishes a list of chemicals known to cause birth defects, cancer, and other health issues.

~900 The number of potentially harmful chemicals on the EHHA list.

The law could affect ANYONE who does business in California — and we take that seriously.

Businesses that sell goods in California must comply with Prop 65, such as posting a warning if a product contains certain levels of a harmful chemical on the list.

Our company manufactures innovative products designed for use in billboards and signs. To ensure that our products are in compliance, we put them to the test. We commissioned a leading, multinational inspection, product testing and certification company to conduct wipe testing on products for the presence of chemicals on the EHHA list.
